Mildred B. Wilkins is founder and president of Home Ownership Matters, LLC. Wilkins is a 1973 graduate of Alabama State University with a bachelor of science in business. Wilkins's real estate career began when she was licensed as a salesperson in 1992. She began active real estate sales with the F. C. Tucker Company in January 1993. She became a Foreclosure Specialist with Fannie Mae in 1999, specializing in selling foreclosed properties. She was recognized as Fannie Mae's first national "Rising Star Rookie Broker of the Year" in 2000. This award was presented at their national convention in Dallas, TX 2000.

She has received loss mitigation training from Neighborworks America, Legal Services, Fannie Mae and HUD.

In 2002, Wilkins founded Home Ownership Matters, LLC (HOM) as a way to reach both professionals and consumers with educational programs about home ownership. The information provided by HOM is a means of addressing the escalating problem of foreclosure faced by many states in the country and Wilkins currently travels extensively with a message of educational intervention.

She is recognized as a national expert on the issues of foreclosure intervention and predatory lending. Wilkins is a speaker, trainer and certified continuing education instructor for Indiana, Ohio, Colorado, Nebraska, and Kentucky. She is author of numerous booklets, including the "Consumer's Guide to Predatory Lending" published in July 2002, and has created an extensive website which is valuable to both professionals and consumers.

She is in demand as a Foreclosure Intervention speaker and trainer for real estate professionals and attorneys across the country. She began offering the Foreclosure Intervention Specialist certification program in the fall of 2005.
